Please provide a short statement explaining why you would like to join the accreditation register and why BSAS should support / approve your application.

#### Management

If you are managing any projects or activities as part of or related to your studies/course(s) please provide a summary of the activity and your role / involvement.

#### **Current Studies**

Provide details of your current studies and course(s).

#### **Other Competencies**

You can use this space to include any other relevant competencies and / or information, for example:

- Do you have or are you working towards a Duke of Edinburgh 'Gold' Award?
- Do you volunteer with the Territorial Army?
- Have you attended a BSAS course (i.e. BSAS R and Stats Workshop)?
- Are you a member of a local sports team?
- O Do you volunteer at a charity?



#### References

Please supply one referee: either your current supervisor or your course tutor. It is advisable to inform him / her that he / she will be approached for a reference to confirm your suitability to apply for the BSAS Register.

#### Conclusions

Complete your form, save it, then a couple of days later re-read what you have written as if you are assessing an anonymous application, or ask a colleague to look over it.



#### **Guidance with applications**

If you would like further support and guidance with your application, you can contact BSAS.

#### Assessment

Should an Assessor be unsatisfied with the information provided you will be advised of this and of any changes that have been suggested before your application goes to the next stage. At this point you may choose to act on these changes, either by accepting them or by providing more relevant information and detail. Or, if there is no response from you, your application will go to the next stage in the procedure.

There will be a panel meeting where another group of three to four persons from the register will look at a group of applications and make a final decision on the applications and assessments before them. You will be told either:

- You have met the criteria for registration but with the following changes
- That you have not yet met the criteria for registration

If there is no response from you - BSAS will proceed as per the Panel's decision.
